**3. Applicant Eligibility**

Applicant must be a United States Citizen and a licensed dental hygienist.

Applicants must be active members of WCDHA

Applicant must live in the area of Florida directly impacted by Hurricane Ian

A. Applications must be received on or before Monday, December 5, 2022, AT 12:00 PM  
Late applications will not be considered for funding.
